## Current Situation about the WBC International titles up to September 1st

(Ukraine)

Heavyweight Andrii Novytski

Novytski won the vacant WBC International title last July 27th in Melrose (Boston US). His next fight on September 20th in Melrose (US) against Shawn Laughery will be a non-title bout.

## Bridgerweight title vacant

The vacant WBC International Bridger-weight championship was to be held in Australia promoted by former world champion Danny Green last June 12th in Darling Harbour (Sydney, Australia) between Kris Terzievski and Tyson Pedro. Unfortunately, due to a fracture to Tyson's right elbow, Danny had to postpone several times this title bout. Now, it seems that co-promoter Jason Lappin will be able to stage the championship next November 1st. More details to come soon.

Silver title vacant

The vacant championship is going to take place in Köln (Germany) next September 7th: Davide De Brito vs Ali Kiydin.

Cruiserweight Roman Fress (born in Kazakhstan)

Roman Fress scored a UD10 against Yasin Basar last August 24th in Magdeburg (Germany) to win the vacant crown.

Silver champion Yusuf Sultanoglu (Germany-Turkey)

Lightheavy Ezra Taylor (UK)

Ezra Taylor won the vacant WBC International Lightheavy weight title when he outpointed Spain's Carlos Alberto Lamela last July 20th in Birmingham.

Silver title Branimir Malenica (Germany)

Branimir will have a non-title bout next September 7th in Köln (Germany)

Supermiddle Luka Plantic (Croatia)

Luka Plantic will defend this title next September 7th in Köln as reported above.

Silver champion Serhat Güler (Turkey)

Serhat will be defending his belt next September 12th in London against Argentina's Abraham Gabriel Buonarrigo as reported above.

Middleweight vacant

Aaron McKenna was stripped for failing to defend the belt in more than one year since he had won the vacant belt.

Silver title Samuel Nmomah (Nigeria)

Samuel retained his title last July 14 in Sequals (Italy) by outporting Ukraine's Oleksandr Shyiti.

Superwelterweight Ermal Hadribeaj (Albania)

The champion will defend his crown next September 7th in Köln (Germany) against unbeaten Younes Zarraa as reported above.

Silver champion Stephen McKenna (Ireland)

Unbeaten Stephen McKenna (Ireland) won the vacant Silver belt in a dramatic fight against Joe Laws (UK) last August 3rd in Barnsley (UK). Promoted by BOXXER of Ben Shalom, the vacant title bout saw both fighters visiting the canvas in the first round. Laws won the sencond round, but McKenna dropped him twice in round three and the referee decided that enough was enought after the loser was floored for the third time in the same session (cornerman threw in the towel).
